Dear Park Patron:

The San Joaquin County Parks and Recreation Department is offering an "ANNUAL PASS" for "DAY USE ONLY." This pass allows entry into six (6) San Joaquin County Parks, such as Oak Grove Regional and Micke Grove for one (1) year. This means "free" entry into any San Joaquin County Park (Does not include camping.)

The "Annual Pass" is valid for only one vehicle and two pets at a time, unless endorsed for a trailer or other towed vehicle. The cost is only \$70.00 and is valid for one (1) year from the date of issue. An additional \$30.00 is charged for your towed vehicle.

"Annual Passes" make excellent gifts. These parks feature special sites, such as the Japanese Garden, Museum, fishing areas, boat ramps, and many other activities that are available, again at no vehicle entry charge to you.

On the reverse side is a "Request Form." Just fill it out, sign it and return it to the Park Office. Your "Annual Pass" can be mailed directly to you or picked up at the Park Office. If we can be of further assistance, please feel free to contact us at (209) 953-8800 or (209) 331-7400.

**ANNUAL PASS INFORMATION
"DAY USE ONLY"**

1. For "free" vehicle entry into a San Joaquin County Park you must have your "Annual Pass" hanging from your rear-view mirror so it is clearly visible from the outside of your vehicle.
2. The "Annual Pass" is valid for only one vehicle and two pets at a time in the park unless endorsed for a trailer or other towed vehicle.
3. The County of San Joaquin is not responsible for the security of your "Annual Pass" or your vehicle and its contents.
4. Passes will neither be replaced nor refunded. Lost passes are treated as a new applicant with corresponding fees.
5. Abide by all Park Rules and posted restrictions. Failure to adhere to these annual pass rules or park rules and regulations may result in revocation of the pass without a refund.
6. This pass is valid one (1) year from the date of purchase, for only vehicles driven by the applicant or their spouse listed on this request form. This pass is not transferable.
7. "Annual Passes" cannot be used for camping, or any other purpose. Only for "Day Use." It may not be valid during special events, or activities.
